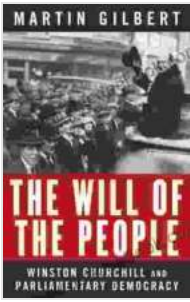


# The Will of the People: A Deep Dive into the 2023 State of the Union Address

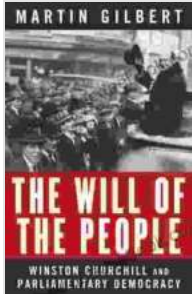
